Approval of the Minutes of the March 31, 2009 Meeting

Treasurer's Report:

Mr. Markowski presented the report to the Members for their consideration.

- As of March 31, 2009, the Corporation had \$ 2,944,967 in its bank accounts and \$ 247,372,657 in investments. No budget certificates or vouchers were pending.
- The entrance conference for the Single Audit has been held. The Single Audit will cover the Section 8 and HOME programs
- Field work for the Corporation's independent audit will start right after Memorial Day.

Report of the President of the Office of Community Renewal

Mr. Rabito and Ms. Hammond presented the report to the Members for their consideration

Highlights:

- **Applications have been received for the 2009 Competitive and New York Main Street funding round and recommendations for awards are expected to be made to the Members by July 22. Microenterprise activities have been moved to the Open Economic Development Round and new home construction and comprehensive activities have been discontinued.**
- **HUD has issued the program requirements for the CDBG Recovery efforts. These will require the amendment of the 2008 Action Plan because the funds may only be awarded to recipients of 2008 CDBG awards. The amendment process has been streamlined. Awardees must be able to go to contract within 120 days of the day the funds become available. There are some inconsistencies in the timing requirements which HUD is expected to correct by technical amendments. The funds must be expended by September 30, 2012. HUD is encouraging stand alone projects. The emphasis is to be focused on hard infrastructure development and to increase economic investment and job creation. Reports will be required within 10 days after each quarter. The Office of Community Renewal expects to make recommendations for awards at the time recommendations for the 2009 Competitive Round are made. The Corporation is working with other**

agencies to coordinate their efforts to promote the best use of the funds that have been made available.

- Ms Lago stated that she will ask the Governor’s Working Group to coordinate and expand interaction with small businesses to include the Corporation’s funding of microenterprise activities in its review.
- The federal 2010 budget proposed by President Obama increases funding for the CDBG program to a level not seen in the past six or seven years.

Community Development Block Grant Program Awards

Mr. Rabito presented the resolution to the Members for their consideration.

- Mr. Rabito presented a summary of the proposed awards.
- The site of the activity will be at the Air Industrial Park, not the former air force base as stated in the briefing reports.
