ASSETS FOR INDEPENDENCE PROGRAM

WHAT IS ASSETS FOR INDEPENDENCE?

Assets For Independence (AFI) is a downpayment assistance program for income-eligible first-time home buyers. Those enrolled save toward either a single-family home at a 4 to 1 matching grant of up to \$7,500.00 or a multi-family (2-4 units) home at a 6-1 matching grant of up to \$11,250. Both savings options allow clients 12-24 months to complete their savings goal. AFI clients must attend home buyer education classes and be mortgage-ready upon completion of their savings plan.

WHO IS ELIGIBLE FOR AFI?

Eligibility is based on household income relative to federal guidelines (see chart below). Those who apply must have a stable source of income from employment or self-employment. Once your eligibility status is confirmed it will not be revoked if your income changes during the savings term. However, you must remain employed or self-employed (full-time or part-time).

WHAT SIZE HOME CAN I PURCHASE?

Under HUD guidelines, Section 8 consumers may purchase a single family home. Other AFI consumers may purchase a one to four family home. There are no recapture provisions or liens placed on the home.

WHERE IS MY AFI SAVINGS ACCOUNT OPENED?

AFI savings accounts are opened, free of charge, at Chase

Bank and monitored by DHCR. Clients are not obligated to obtain their mortgage with Chase Bank and may shop elsewhere for affordable mortgages.

HOW MUCH MUST I SAVE FOR THE MAXIMUM GRANT OF \$7,500?

AFI monthly savings deposits range from \$78.13 to \$156.25 depending on the length of the savings term. Note: A minimum savings plan is also available at \$25.00 per month.

WHAT CAN HOMEBUYER EDUCATION AND FINANCIAL COUNSELING CLASSES TEACH ME?

The mandatory homebuyer education and financial counseling classes teach AFI clients how to shop for affordable mortgages, how to work effectively with realtors and home inspectors, and how to gain economic independence by transitioning from a reliance on credit to savings. AFI clients who purchase a multi-family home must attend landlord training.
